
Sir,

I am directed to convey the sanction of the President of India for payment of ₹27695.28 crore (₹ Twenty Seven Thousand Six Hundred Ninety Five crore and Twenty Eight lakh only) as indicated in column 1 D of the enclosed statement being the payment of States' share of net proceeds of all shareable Union Taxes and Duties on Thirteenth Finance Commission's recommendations payable to the State Governments due in June, 2014.

2. **From the above amount, you are requested to adjust all outstanding amounts on account of defaulted repayments to Department of Economic Affairs/Department of Expenditure due from the State Governments to the Centre, and the balance after adjustment of the outstanding dues may be paid to the State Governments in cash.**

3. In view of the urgency of the matter, you are requested to advise the Reserve Bank of India, Central Accounts Section Nagpur immediately by Telex for crediting the amounts to the accounts of the respective State Governments as on 2nd June, 2014 under intimation to the undersigned, to the Finance Department and to the Accountants General of the States.

4. **Payment may kindly be made immediately.** In case of Sikkim, payment may be made in their Account No. 101016 of Central Bank of India, Janpath Branch, New Delhi.






